

RAFFLE-TERMS AND CONDITIONS

By participating in this Sponsor Giveaway Contest (this “Contest”), the person entering their name and personal information to participate in the Contest (“you,” “your,” the “participant”) acknowledges and agrees to the following terms and conditions (the “Terms and Conditions”) applicable to and governing your participation in this Contest organized by The Capital Markets Company Limited (“Capco” or “Sponsor”):

1. ENTRY REQUIREMENTS

An entry fee of \$20 is required to participate in this raffle.

2. ELIGIBILITY

Participants must be 18 years of age or older and live in the U.S. to participate in the Contest.

3. HOW TO ENTER

To enter the Contest:

- The participant must pay the \$20 entry fee and submit a guess as to the number of golf balls in the jar. Participants may submit only one (1) guess.
- A limit of only one (1) entry per person is permitted. Incomplete, duplicate, automated, fraudulent, or inaccurate entries may be disqualified.

4. WINNER DETERMINATION

The winner will be the participant whose guess is closest to the actual number of golf balls in the jar without going over. If more than one participant submits the same qualifying guess, a tie-breaker question will be used to determine the winner.

- The winner will be determined based on the accuracy of the participant's submitted guess and not by random draw;
- Only one (1) prize is available, and only one participant will be declared the winner;
- The winner will be determined by the participant whose guess is closest to the actual number of golf balls in the jar without exceeding the actual number.

5. PRIZE AWARD CONDITIONS

The participant acknowledges and agrees that:

- Participation does not guarantee winning;
- No representations or warranties have been made regarding the likelihood of winning; and
- The winner will receive the jar of golf balls and a putter, which will be awarded solely in accordance with these Terms & Conditions

6. VOLUNTARY PARTICIPATION

Participation is voluntary, and participants may choose not to enter or may withdraw prior to winner determination by providing written notice to Sponsor.

7. RESPONSIBLE PARTICIPATION ACKNOWLEDGEMENT

The participant acknowledges and understands that participation in games of chance may involve risk and can become addictive. The participant further acknowledges that this Contest is free to enter and does not require any gambling, wagering, or payment to participate.

The participant acknowledges and understands that responsible gambling resources and support services are available. Participants should enter responsibly and only if participation is lawful and appropriate for them. Any individual who believes participation in prize-based promotions may negatively affect their well-being should refrain from participating. Individuals who are subject to any self-exclusion program should not participate.

8. PRIZE CONDITIONS

The prize is non-transferable, has no cash value unless expressly stated otherwise, and may not be substituted except at the Sponsor's discretion. The winner will receive a jar of golf balls and a putter. The Sponsor reserves the right to substitute the prize with a prize of equal or greater value if necessary.

9. RELEASE AND LIMITATION OF LIABILITY

By participating, the participant irrevocably and unconditionally releases, waives, acquits and forever discharges the Sponsor, and its affiliates, and their directors, officers, employees, agents, and representatives from any liability, claims, losses, or damages arising from participation in the Contest or acceptance or use of any prize, except where prohibited by law. To the maximum extent permitted by law, the Sponsor shall not be liable for any indirect, incidental, consequential, or special damages, and any direct liability shall not exceed \$10.00 per participant.

10. PRIVACY

11. RIGHT TO MODIFY OR CANCEL

The Sponsor reserves the right to modify, suspend, or cancel the Contest at any time if necessary, due to technical issues, fraud, legal requirements, or other circumstances.

12. PLACE OF CONTEST

The participant acknowledges and agrees that this Contest is conducted in, and is subject to the laws of, the State of New York.
