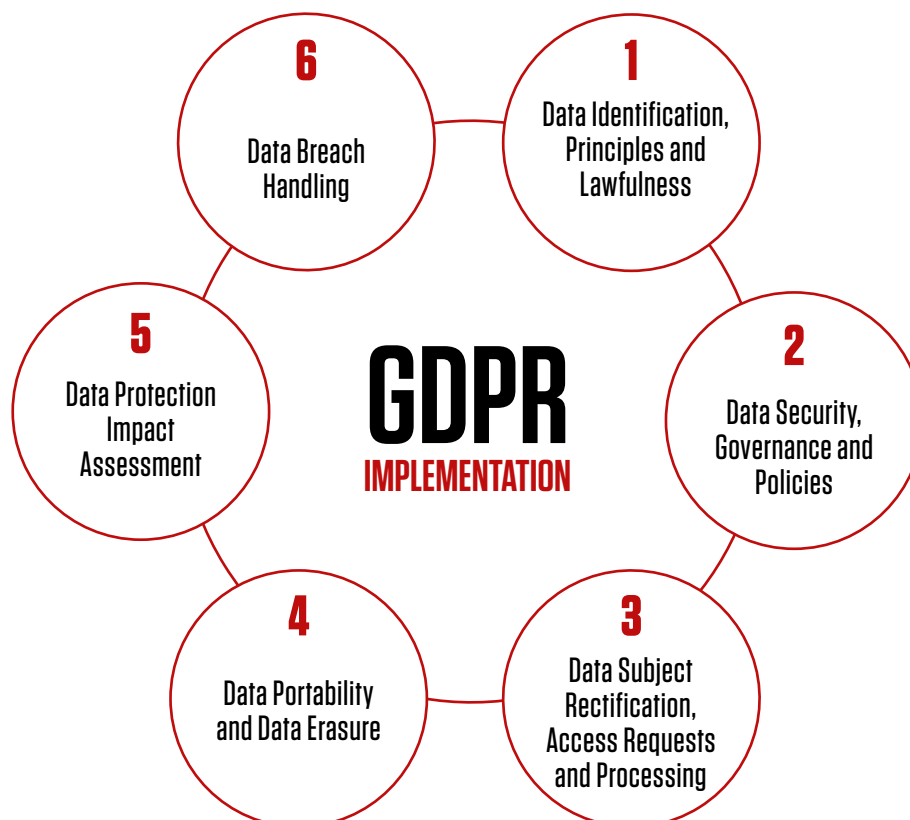

Key challenges to be addressed

- 1** Lawfulness assessment across the organization, as well as the implementation of mitigating measures.
- 2** Update security standards, governance structure and policy framework.
- 3** Enablement of data subject access requests through data identification and
- 4** Extraction of GDPR relevant personal data and portability to data subject. Process data erasure.
- 5** Identification of need and execution of data protection impact assessment.
- 6** Identification, handling and reporting of data breaches (72 hours response time).
